Programme Tech4Trust

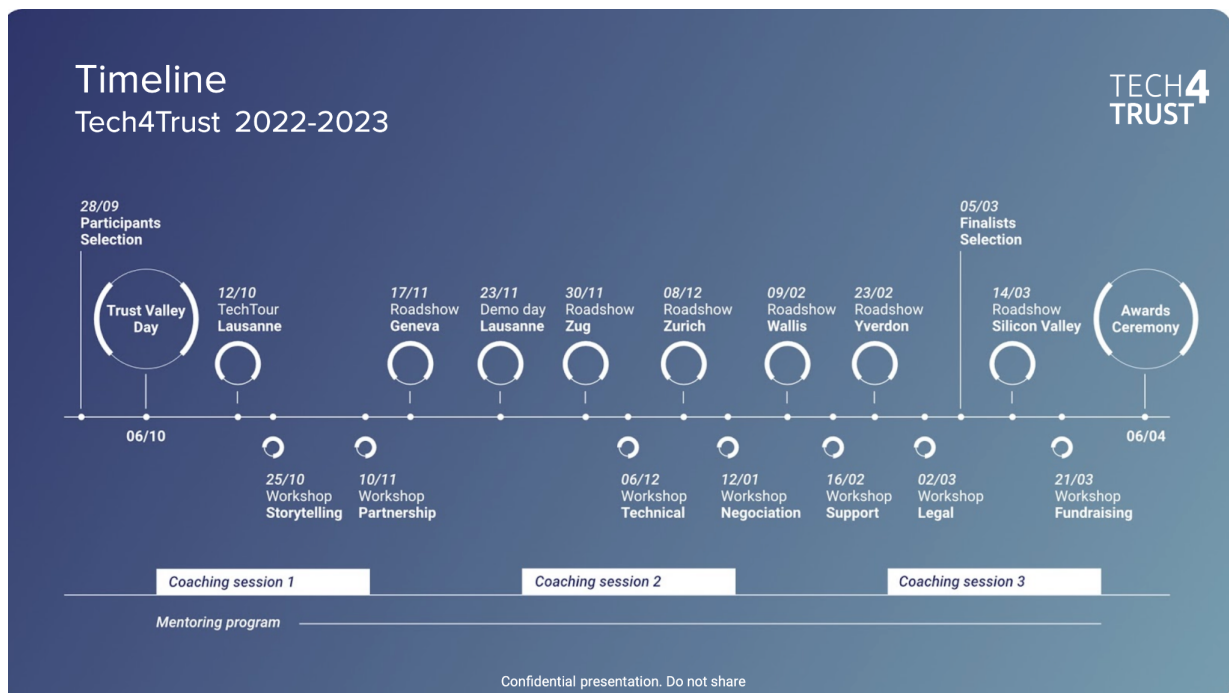
Le programme comprend 9 événements “roadshows” qui permettent aux entreprises du programme de présenter leur produits et d’entrer en relation avec des investisseurs, de nouveaux clients ou des partenaires potentiels sur des événements dédiés. Ces roadshows du programme ont lieu aux quatre coins de la Suisse, avec des arrêts à l’international, notamment à la Silicon Valley, en Norvège et à Singapour.

Une autre partie du programme est dédiée à l’acquisition de compétences d’affaires clefs sous la forme d’une dizaine de “workshops”. Ces ateliers sont dispensés par des experts de l’industrie dans des domaines tels que la vente, la gestion, les aspects juridiques et la collecte de fonds.

S’ajoutent à cela des programmes de coaching et mentoring par des experts qui accompagnent et conseillent les startups tout au long du programme dans une démarche individuelle. 3 prix d’une valeur totale de CHF 160’000 francs sont également décernés en fin de programme aux trois meilleures entreprises du programme.
